- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total QUANTITY. - 2) Delivery Days mentioned as 365 Days on GeM Bid/Contract is actually Period of contract & not delivery period.
- 3) Successful bidder shall submit a Security deposit -cum-Performance guarantee equi valent to 5% of the guranteed order value as per Tender T&C
- 4) GTG-HRSG commissioned & has been taken inline for power supply instead of Turb o Generator of CPP. CPP Cooling Tower/Water System will be kept under preservati on for taking inline incase of extreme exigency as per requirement of NFL.

- 5) CPP Cooling Tower shall be preserved at "NIL" heat load throughout the year so tha t in case of requirement, it can be taken in line for Captive Power Plant. CPP cooling tower water preservation procedure shall be provided by bidder. With the recomme nded procedure CPP cooling tower may be preserved for one year. The bidders may Quote accordingly. However If NFL decides to stop preservation of CPP cooling towe r, the same may be stopped with two months prior intimation to the Party.
- 6) Ammonia Cooling Tower & Urea Cooing Tower operations considered for 365 Days and CPP Cooling Tower operation considered for 90 Days (Ninety Days)
- 7) Total Quantity of chemical to be Quoted/Supplied by the Vendor Shall be adequate for 365 days operation of CT-1 & CT-2 and 90 days operation for CPP cooling tower s. In case party quote for any lesser period /Quantity of chemicals ,the party has to maintain the required parameters as per NIT T&C for operating CT-1,CT-2 & CPP- CT for the period mentioned above by suppling free of cost the required chemicals with out any conditions.

8) PRICE BID

- (i) Bidder has to quote Price for Total Cooling Water Treatment Package on GeM porta I as per Clause 4.2 of Technical Section -C . Please note that quoted price on GeM shall be on all inclusive basis i.e. including taxes , duties , local levies /transportati on etc.
- (ii) However Bidder must submit Item wise price breakup of chemicals on GeM Portal a s "Financial Document" along with their submission of Price for Total Cooling Water Treatment Package on GeM portal. Bidder should ensure that this Price Break Up is not submitted by them alongwith their technical bid failing which risk & responsibil ities for losing tender/price confidentially shall rest with tenderer. NFL shall have no obligation as consequences thereof

(Format for submitting Price Break-up as "Financial Documents" is given in Annex ure- A of commercial section of Tender document. This must be submitted on Bidd er's letter head with sign & stamp of Bidder).

- (iii) In case of any mismatch between Price for Total Cooling Water Treatment P ackage submitted by bidder on GeM portal & Item wise price breakup of che micals submitted as "Financial Document" with their price bid, then Price fo r Total Cooling Water Treatment Package submitted by bidder on GeM portal shall be final & binding and bidder has to re-submit Item wise price breakup of chemicals ("Financial Document") through email.
- (iv) In case of any mismatch between Quantities of Chemicals submitted by bid der as per Annexure-B with their Technical Bid & Quantities of chemical men tioned in "Financial Document", submitted by bidder with their price bid, the Quantities of Chemicals submitted by bidder as per Annexure-B shall be

final & binding and bidder has to re-submit Item wise price breakup of chem icals ("Financial Document") through email.

- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
