In case of applications/bids from un-enlisted contractors, where scanned copies of requisite DD/Bankers cheque towards cost of tender has been uploaded, but physical copies are not received by the stipulated date, finance bids will not be opened. Name of such contractors alongwith complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid.

22. In case of applications/bids (enlisted contractor / as well as un-enlisted contractors) where scanned copies of requisite Earnest money (as applicable) were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.

23. In case of rejection of technical bid, contractor may appeal to next higher Engineering Authority i.e. AddI DGBR (East) on email <u>bro-adgbr.east@bro.gov.in</u> against rejection whose decision shall be final and binding, However, contractor/bidder shall not be entitled for any compensation whatsoever on account of rejection of technical bid.
