- 1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Balance 10% payment shall be released after successful commissioning within 30 days after acceptance of same to the satisfaction of engineer in-

charge.

If commissioning is not completed within 6 months after receipt and acceptance of complete material at N FL site, for reasons not attributable to party, then, balance 10% payment shall be released after 6 months of receipt and acceptance of complete material at NFL site.

b. Erection, Commissioning and Testing Charges: 100% of EC&T charges including taxes shall be paid after successful commissioning with satisfaction of Engineer in Charge. Payment of complete EC&T charges shal I be released after successful commissioning and testing of complete panel within 30 days of submission of all required documents.

2. Evaluation criteria:

4. Eligibility Criteria:

Quotation from bidders not meeting the eligibility criteria (attached as Annexure E) shall be rejected. Bidd ers shall upload complete, legible and unambiguous documents (duly numbered) asked in the eligibility criteria along with their offer. NFL reserves the right to complete the evaluation on the basis of details furnish ed by the bidder, with or without seeking any additional supporting documents/ clarifications.

- 5 . Material shall be guaranteed for a period of 12 months from the date of installation/commissioning or 1 8 months from the date of supply whichever is earlier and that Guarantee Certificate to this effect will be s ubmitted along with dispatch documents/ supply.
- 6. Pre-dispatch inspection of the material shall be done at party's works by NFL representative. Party shall inform NFL for the same at least 4 weeks in advance.
- 7. Erection and Commissioning job will be carried out after site clearance (tentative in 2023 ATA) or earlier from the date of award of PO by NFL. The same will be intimated to party 7 to 10 days in advance.
- 8. On- site training of 2 NFL technicians and 1 NFL Engineer for operation and maintenance of the Panel sha II be provided by the party.
- 9 . The complete dismantling job of old panel and installation, testing, commissioning of newly supplied 41 5 V LT PMCC panel as per the satisfaction of engineer-in charge shall be completed within 14 days from the day of site clearance.
